REGISTRATION REQUIREMENTS

Your horse must meet one of the following three criterias:

- It must be the progeny of a registered Walkaloosa stallion and a registered Walkaloosa mare or:
- Be a horse showing Appaloosa coloring and demonstrating the ability to perform an intermediate gait other (rack, foxtrot, running walk, singlefoot, pace, etc.) other than the trot. "Gait" must be certified by a professional trainer or by a veterinarian or:
- Be a horse of verifiable Appaloosa and gaited horse blood. Horses that do not show Appaloosa color characteristics in pictures taken from at least ten (10) feet, or that do not "gait," are eligible for identification (breeding purposes) papers only.

The name of any registered horse, regardless of age can be changed upon payment of \$20.00 provided it has not ever sired or produced a foal.

Any person or persons who shall willfully register or record a false pedigree shall be forever barred from making further registrations and the registration of such false pedigree shall be cancelled.

All Applications for Registration must be typed or printed in ink. The applications become an important part of the records of the Association. Every care should be exercised in providing accurate information regarding dates, detailed description of markings, etc.
